Thank you for choosing Cory W Johnson CPA LLC to assist with the 2017 taxes for Profound Gentlemen, Inc. This letter confirms the terms of the engagement and outlines the nature and extent of the services we will provide.

We will prepare the 2017 federal and state income tax returns for Profound Gentlemen, Inc. We will depend on management to provide the information we need to prepare complete and accurate returns.
